Greeniosk is complete system that allows Medical Marijuana (MMJ) Dispensaries to document and provide an audit and verification of each individual transaction that a MMJ dispensary is doing. Currently the majority of MMJ Dispensaries have limited bank service access. This is mainly due to the Racketeer Influenced and Corrupt Organizations Act, commonly referred to as the RICO Act or simply RICO, which is United States Federal Law that provides for extended criminal penalties and a civil cause of action for acts performed as part of an ongoing criminal organization. RICO was enacted by section 901(a) of the Organized Crime Control Act of 1970.

Currently MMJ Dispensaries are doing between \$500,000 and \$5,000,000 in revenues per year with the majority of the transactions made in cash (a limited number of dispensaries are accepting debit transaction). Since the majority of the banks are not doing business with these dispensaries, that also eliminates the majority of the potential bank accepting credit transactions for the purchase of MMJ. **Greeniosk** will provide a level of compliance and auditing for each transaction that will reverse this impasse.

Method

Greeniosk is a complete payment system that is divided in two major parts. When each MMJ client determines the amount and cost of the merchandise they want to purchase, they go to a **Greeniosk** Kiosk and follow the instructions to purchase a voucher that will be redeemed for the desired merchandise.

This is made in 4 simple steps. The first step is to answer the following four questions from the touch screen by "yes" or "no":

1. Are you 21 years or older?
2. Do you have a valid Driver's license in your possession?
3. Do you have a valid medical marijuana card in your possession?
4. Upon Meeting the above conditions you must also agree to insert U.S. Currency into the kiosk, aware that NO CASH REFUNDS are available. Any unused funds will be credited to a secondary voucher issued by the kiosk and can be used toward your next transaction.

The second step is to select the payment method. We will be offering up to four payment methods: Cash, Debit, Credit and **Greeniosk** Card or Ecard. When you have made your selection you either insert bills into the **Greeniosk** or swipe your card and make your transaction.
